



REGISTRATION WAIVER

IMPETU DANCE CENTER (IDC) 2016-2017

Please read carefully the following statements and write your initials where indicated. Please share this information with your with your child/children, so they are aware and completely understand the rules that IMPETU Dance Center (IDC) works under. If any of these policies are not completed, the registration of the child/children won't be considered valid. Each family must complete this waiver every school year and it will be valid for all the classes until JUNE 2016. With your signature, you agree with all our policies below. INITIALS ____

Registration & Tuition Policy. We will charge a non-refundable registration fee of 35\$ for new students and 55\$ for siblings, VALID UNTIL JUNE 2016. Tuition is due the first day of each month. If the payment is not in our office on or before the 8th day of each month a 15\$ late fee will be applied to your account. TUITION IS THE SAME EACH MONTH. Holidays, 3 or 5 weeks months, all of these are considered a FULL calendar month. Full payment is expected for the month of **December** and **June**. INITIALS ____

Checks Policy & Auto Pay. IDC will accept automatic payments (Auto Pay) using credit cards by filling the IDC Automatic Payment Form. Auto Pay will be set up to charge your account any day between 1st and 8th each month (you choose). A 30-days notification is needed in order to make any change in this service. If you decide to withdraw Auto Pay, you will need to notify two weeks prior. You will be charge for the regular monthly payment, without Auto Pay discount for the rest of the year. IDC accepts check and in case of non-funded checks IDC will charge an extra 35\$ fee. INITIALS ____

Adding & Dropping Classes. Registration is a COMMITMENT with the selected class(s) since the beginning of the school year in IDC, until JUNE 2016. **If you want to make any changes by adding or dropping any class, the representative must notify through a note or call directed to IDC before the first (1st) day of the month. Otherwise, we will be charging your tuition monthly until the notification is been done.** If the Spectacle is done before JUNE, the child/children must attend to their respective class(s) until school year is over. INITIALS ____

Dress Code. All the students must follow the dress code to attend their respective classes in IDC. It is required clothes and proper shoes, so each teacher is able to evaluate and appreciate the moves of the dancer. BALLET classes require black leotard, pink tights, split sole ballet slippers and a high ballet bun. JAZZ classes require leotard, black crop top, black jazz pants or shorts and black jazz shoes. Jeans are not allowed in URBAN classes. Please limit jewelry. INITIALS ____

Costumes/Shoes. All IDC performances and spectacles will require costume and shoes. The advanced groups could require additional accessories or elements according to their choreography. An extra fee will be notified in advanced prior the Spectacle. Every dancer will require this costume(s) and shoe(s) during performances season and then everyone will be able to keep them. INITIALS ____

Absences & Drop In The tuition won't change for any absence(s) the student had during the month. Missed classes can be made up by notifying the Director of IDC and selecting any similar genre class or same age group class in a period of (30) days. The student(s) MUST notify the teacher that they are having a made-up class. If the student wants to take that class as an INDIVIDUAL CLASS, the student must notify the Director so it can be added to the teacher's folder. INITIALS ____

Drop-Off/Drop-Up Policy. To ensure the safety of our students, they should not wait more than 10 minutes to be picked up at IDC after their class is done. The guardian/parents will be the only responsible for their child/ children once finished the class. IMPETU Dance Center, including the teachers, and employees, won't be responsible for any of the students, after they leave IMPETU Dance Center. Please do not park in the

handicapped parking spot to drop off or pick up your child/children, or block the parking lot, park in a regular parking spot to wait for your child/children. **INITIALS** ____

Assumption of Responsibilities and Risk. Dance, as any sport, can cause injuries; please be aware of these. I understand the risks and assume that these activities involve. I understand the risk and assume the responsibility of my child/children. I hereby waive all claims and release the owners, directors, teachers and employees of IMPETU Dance Center from any liability of any injury or loss incurred. I accept that these activities are executed by my own risk and accept the responsibility. I waive the right to any legal actions for any injury sustained on IMPETU Dance Center resulting from any activity conducted by the students before, during or after class time. **INITIALS** ____

Case of Emergency. Parents or Guardians may trust in IDC Staff and Personnel to take action in case of any emergency their kids may encounter for as long as parents or guardians comes and/or a doctor arrives. **INITIALS** ____

Terms and Conditions. THE CLIENT accepts paying an extra financial fee of 1% monthly for all debt accumulated with IMPETU Dance Center. **ATTORNEY FEES AND COSTS:** If any legal action is necessary to enforce the terms of this Agreement, or if it is necessary to employ the services of an attorney to enforce the terms of this Agreements, the party in default or in breach hereof agrees to pay the other party's reasonable attorney's fees and court costs in addition to any other relief to which it may be entitled if Customer fails to pay any amounts owing hereunder when due, or otherwise breaches any terms of this Agreement. Customer agrees to pay up to a 40% collection expense incurred by Backstage, IMPETU Dance Center is in attempting to collect such amounts from Customer, in addition to the aforementioned attorney's fees and costs. **INITIALS** ____
